In consideration of Long Beach Yacht Club ("LBYC") accepting my entry in the Race or otherwise permitting me to participate in the Race, I agree as follows:

1. COMPLIANCE WITH RULES: I agree to be bound by the Racing Rules of Sailing, ISAF Offshore Special Regulations, and with all rules and regulations of LBYC, the USCG, the Government of Mexico, and any other rules that govern this event. I agree to comply with the Regulations for clearing and entering into Mexico and the United States, as arranged between the Organizing Authority and the appropriate authorities.

If my yacht is moored / stored at LBYC before, during or after the Race, I understand that LBYC may move the yacht or adjust and/or modify the mooring, and LBYC is hereby released from any liabilities and shall incur no liability as a result of such action.

2. CONSENT: I hereby grant LBYC the right to use my name, picture, image, voice and sports performance in the possible creation of promotion and advertising for LBYC and it's sailing programs and other regattas. This consent is given only for promotion and advertising of LBYC and it's sailing/racing programs and other regattas; consent is not given with respect to the promotion and advertising of any commercial product or service.

3. CONDUCT AND CERTIFICATIONS: I am aware that each skipper is responsible for the conduct of his crew at all times, especially when ashore in Mexico. I agree not to sail in hazardous conflict with commercial vessels or shipping. I hereby certify that all members of my crew, including myself, are able to swim.

4. WAIVER of LIABILITY: I, for myself, my heirs, personal representatives and assigns forever release, remise, discharge and agree to save and hold harmless and indemnify LBYC, it's members, directors, officers, agents, employees, volunteers and owners and lessees of premises, upon which any and all of the race-related activities and social events will be held (both in Mexico and the United States), the participants therein and the owner and lessees of all racing equipment used therein (herein referred to as the "Releasees") of and from any liability, claims, actions, and possible causes of action whatsoever, including negligence of any of the foregoing that may accrue to me, my heirs and personal representatives and assign from every and any loss, damage and injury (including death) that may be sustained by me, and my property while in, about, and enroute into and out of the premises and properties upon which the Race and it's related activities and social events are held.

5. ASSUMPTION OF RISK: I am aware that the activities involve inherent risks and potentially hazardous conditions which may include, among other things, maneuvering a boat on deep waters, strong winds and high waves, sudden unexpected immersion in deep waters, and collision with other watercraft, floating debris and objects, and/or stationary objects such as docks, pilings, piers and buoys. I ACCEPT ANY AND ALL RISKS TO MYSELF OR INJURY, DEATH, AND PROPERTY DAMAGE ARISING FROM PARTICIPATION IN ANY OF THE RACE-RELATED ACTIVITIES, AND THE USE OF FACILITIES AND PROPERTY OF LBYC, AND THE USE OF ANY FACILITIES USED IN CONJUNCTION WITH THE RACE AND IT'S RELATED ACTIVITIES AND SOCIAL EVENTS (BOTH IN MEXICO AND THE UNITED STATES), SPECIFICALLY INCLUDING ANY INJURY OR DAMAGE CAUSED BY THE NEGLIGENCE OF ANY OF THE RELEASEES.

6. INDEMNITY AGREEMENT: I agree to indemnify, defend and hold the Releasees harmless from any loss, liability, damage or cost, including reasonable attorney's fees, they may sustain or incur due to or relating to my participation in the Race and use of the property and facilities of Long Beach Yacht Club, and any property and facilities used in conjunction with the Race or it's related activities and social events, specifically including any such loss, liability, damage or cost resulting from the negligence or the action, of the Releasees.

I HAVE CAREFULLY READ THIS AGREEMENT AND FULLY UNDERSTAND ITS CONTENTS. I AM AWARE THE AGREEMENT INCLUDES A WAIVER OF LIABILITY, AN ASSUMPTION OF RISK, AND AN AGREEMENT BY ME TO INDEMNIFY THE RELEASEES, AND I SIGN IT OF MY OWN FREE WILL.
