



CALIFORNIA DREAMIN' SERIES 2021

San Diego Yacht Club – January 30-31, 2021

St. Francis Yacht Club – March 6-7, 2021

Long Beach Yacht Club – April 17-18, 2021

Notice of Series

1. ORGANIZING AUTHORITY

The Organizing Authority (OA) will be each of the three clubs with events in the series.

2. SCHEDULE

The California Dreamin' Series (CDS) will consist of three match racing events: the San Diego Yacht Club Stop on January 30-31, 2021 in J/22 type boats, the St. Francis Yacht Club Stop on March 6-7, 2021 in J/22 type boats, and the Long Beach Yacht Club Stop on April 17-18, 2021 in Catalina 37 type boats.

3. RULES

The Notices of Race and Sailing Instructions of each event shall apply.

4. ELIGIBILITY AND ENTRY

4.1 Any skipper entered in at least one of the three events is automatically entered in the CDS. There is no entry fee for the CDS. **Skippers who enter all 3 stops shall be given priority for entry acceptance at each stop.**

4.2 Up to eight (8) skippers will be invited to each Stop of the CDS. Skippers may request invitations to one or more of the events.

4.3 The application period for all events opens on December 1, 2020. Skippers may request invitations to individual qualifying events online by clicking on the link at:

5. SCORING

5.1 Skippers shall receive points based on their final rankings in each of the three events in the CDS. Event points shall be allocated as described in the table below. Skippers shall receive zero event points for each event in the series that they do not enter.

Place	Points
1st	100
2nd	75
3rd	55
4th	40
5th	30
6th	20
7th	15
8th	10

5.2 If all three events are scored, a skipper's series score shall be the total of that skipper's points from the Long Beach Yacht Club Stop and the higher points from one of the two other events. If two or fewer events are scored, a skipper's series score shall be the total of that skipper's points from all scored events; no event points shall be excluded. The skipper with the highest series score shall be the winner of the CDS.

5.3 Replace A8.1 with the following:
A8.1 If a series-score tie exists between two or more skippers, they shall be ranked in order of their points in the Long Beach Yacht Club Stop, if it is scored. Otherwise if there is a series-score tie between two or more skippers, each skipper's event points shall be listed in order of best to worst, and at the first place(s) where there is a difference the tie shall be broken in favor of the skipper(s) with the most points. No excluded event points shall be used.

5.4 Replace A8.2 with the following:
A8.2 If a tie remains between two or more skippers, they shall be ranked in order of their points in the last event. Any remaining ties shall be broken by using the tied skippers' points in the next-to-last event and so on until all ties are broken. These points shall be used even if some of them are excluded points.

6. PRIZES

The principal prize for the winner of the CDS will be an invitation to the 2022 Ficker Cup.
